RE: Dog, Cat and Dangerous Dog Ordinance Approved on First Reading

On October 26, 2010, the Blair city council approved on First Reading an amended dog, cat and dangerous dog ordinance.

The city council will consider this ordinance on Second Reading, and perhaps final passage on Third Reading, at their next meeting on Tuesday, November 9, 2010. Additional amendments may also be made at that time.

All city council meetings begin at 7:00 p.m. in the council chamber at city hall.

Following this one page memo is the ordinance only which was approved on First Reading. The ordinance has the legal language amending or adding Sections 6-101 through 6-139, 6-205, 6-401 through 6-403, and the Addendum of Code Violations Bureau Fee Schedule of the Blair Municipal Code.

COUNCIL MEMBER _____ INTRODUCED THE FOLLOWING ORDINANCE:

AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE MUNICIPAL CODE OF THE CITY OF BLAIR, NEBRASKA, WHICH RELATE TO DOGS AND CATS/DANGEROUS DOGS AS WELL AS PENALTIES RELATING THERETO AND AMENDING CERTAIN SECTIONS ACCORDINGLY AS WELL AS THE “ADDENDUM OF CODE VIOLATIONS BUREAU FEE SCHEDULE”; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA:

SECTION 1. That Sections § 6-101 through § 6-121, § 6-205, § 6-401 through § 6-403 of the Municipal Code of the City of Blair, Nebraska are hereby amended, and that Sections § 6-122 through § 6-139 are hereby added in their entirety, all attached hereto as “Exhibit A” and fully incorporated herein by reference.

SECTION 2. That Addendum of Code Violations Bureau Fee Schedule of the Municipal Code of the City of Blair, Nebraska is hereby amended and attached hereto as “Exhibit B” and fully incorporated herein by reference.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. That this ordinance shall be in force and take effect from and after its passage, approval and publication as provided by law.
